Please bring your receipt/confirmation and map showing your space location with you on festival weekend.

Refunds will be made if we are unable to allow vendors due to COVID-19 Provincial Health regulations. If you are unable to attend after your application and payment has been received because of special circumstances (ex. medical or compassionate), you may submit a written request for review to the Icelandic Festival with an explanation.

If the reason is deemed valid, the Festival Executive will consider holding over your fee to the following year. In exceptional cases, where carry-forward is not possible, the Committee will consider refunding a portion of the fee.
