Please bring your receipt and map showing your space location with you on Festival weekend.

If you are unable to attend after your application and payment has been received because of special circumstances (e.g. medical or compassionate), you may submit a written request to the Icelandic Festival with an explanation for your non-attendance. If the reason is deemed valid, the Festival Executive will consider holding over your fee to the following year. In exceptional cases, where carry-forward is not possible, the Festival will consider refunding a portion of the fee. The Icelandic Festival of Manitoba retains the right to refuse any application. If an application is rejected, the full fee will be returned to the applicant.

## 2024 Icelandic Festival of Manitoba Application Rules and Regulations

## General parameters are as follows:

- 1. Space allocation is the sole discretion of the Festival Director. Vendors are not permitted to move without permission.
- 2. The Icelandic Festival is an outdoor festival and is therefore subject to unpredictable weather conditions. The Festival provides no booth or sun / rain cover for vendors and cannot guarantee crowd size or profit.
- 3. The Festival does not provide security and is not responsible for lost, stolen or damaged property.
- 4. We encourage vendors to stock and sell product made in Manitoba and in Canada.
- 5. We encourage vendors to use environmentally sustainable and/or compostable products, where possible.
- 6. Please keep your area clean.

All vendors agree to abide by the following regulations which govern their participation in the Festival:

- 1. Any vendors who have not paid in full by <u>June 30, 2024</u> will not be permitted to attend.
- Vehicles must be unloaded from First Ave thirty minutes <u>before</u> the opening of the Festival each day. Set-up times for each day of the Festival is 8:00 AM to 10:00 AM - vehicles must be out of the vendor area by 9:30 a.m.
- 3. Vendor booths must be taken down each night <u>after</u> 6:00 PM on Saturday and Sunday and before 4:00 PM on Monday. Vendors may stay open later if they wish.
- 4. No overnight camping is permitted in town or in the park.
- 5. Vendors must remain completely within their designated 12' x 12' space. If you require more space you are encouraged to book two booths.
- 6. Subletting of space is not permitted.
- 7. No drug paraphernalia, weapons or merchandise with profanity shall be sold or displayed.
- 7. Any vendors showing up uninvited will be asked to leave.
- 8. Please keep your area clean.
