You will be informed of the acceptance of your application upon review by our committee (approx. 2 weeks). Our goal is to showcase a diversity of vendors and we retain the right of refusal.

Upon acceptance payment is required. You will be invoiced when your application is accepted.

Maps indicating vendor placements will be sent out prior to the Festival. Please bring your receipt/confirmation and map showing your space location with you on Festival weekend.

If you are unable to attend after your application and payment has been received because of special circumstances (ex. medical or compassionate), you may submit a written request for review to the Icelandic Festival with an explanation. If the reason is deemed valid, the Festival Executive will consider holding over your fee to the following year. In exceptional cases, where carryforward is not possible, the Committee will consider refunding a portion of the fee. The Icelandic Festival of Manitoba retains the right to refuse any application. If an application is rejected, the full fee will be returned to the applicant.

2024 Icelandic Festival of Manitoba Cultural Vendor Application Rules and Regulations

All vendors agree to follow these regulations which govern their participation in the Icelandic Festival of Manitoba (IFM).

- 1. Space is allocated by the Culture and Heritage Pavilion committee. Please do not move without permission.
- 2. Cultural vendors will be provided with one 8ft table. If you require more space you are encouraged to book two booths.
- 3. Please be advised that security is not provided.
- 4. IFM is not responsible for lost, stolen or damaged property.
- 5. IFM is primarily an outdoor festival and is therefore subject to unpredictable weather conditions. The Festival cannot guarantee crowd size or profit.
- 6. There will be no subletting of space.
- 7. No drug paraphernalia or weapons shall be sold or displayed.
- 8. Any vendors who have not paid in full by **July 15th**, **2024** will be considered as not attending and have their space re-allocated.
- 9. Please keep your area clean.
- 10. Out of respect for other vendors and the event, we ask that all vendors attend for the full length of the event and have their table open for all opening hours on both Sunday and Monday.
